FREE RESOURCES LICENSING AGREEMENT

PROHIBITIONS

The Licensee shall not sell, resell, sublicense, publish, republish, or otherwise make any Resource available to third parties, whether for commercial gain or otherwise. This includes, without limitation, uploading, hosting, or reproducing any Resource on the Licensee's own website, intranet, app, or any other platform accessible to parties outside the Licensee's organisation.

The Licensee shall not remove, obscure, or alter any Spire Safety branding, logos, or attribution contained within a Resource, except where customisation for internal use requires reasonable modification of headers or footers.
